

2026 WPC x Guelph Holzkünste Giveaway Terms & Conditions

Eligibility

This giveaway is open to residents of Canada aged 18 years and over.

Entry Period

The WPC x Guelph Holzkünste Giveaway begins on May 15th, 2026 and ends on June 8th, 2026. All entries must be received by June 8th, 2026 11:59PM EST.

How to Enter

To enter, participants must complete the giveaway entry form found at <https://wildlifepreservation.ca/guelph-holz-giveaway/>. All required fields must be completed for the entry to be submitted. Additional entries can be gained by liking and commenting on giveaway posts found on Wildlife Preservation Canada's official social media pages, and by sharing the post to the participants' social media story.

Participants may only submit their email address for entry once, but are permitted to have unlimited bonus entries via social media.

Submission of a participant's email counts as a single entry. Liking and commenting on the wall art giveaway posts count as a single additional entry per post engaged with. Sharing the post to the participants' story counts as a single additional entry per post shared.

Chances of winning will be determined based on the total number of entries received throughout the duration of the giveaway.

One (1) winner will be selected at random draw from the pool of entries.
